MONTHLY REPORTS

Financial Report – Brian O'Reilly reported that the numbers are right where they should be in all projections. He will be updating the budget based on student head count and prepare amendments accordingly for December or January.

East Shore Leadership Academy Annual Audit – Patrick Sweeney reported on the annual audit. He explained that it is a public monies representation. The Find Balance (FB) as of 2021-22 was \$522,000.00. Fifty-two percent was spent in the classroom. This is excellent. The FB will decrease once the once the federal funds go away (ESSER, etc.). Uniform budget and accounting are compliant.

Marketing Report – Nancy Gardner communicated she has been posting a lot of the school activities and community resources on Facebook. The target now is geared toward children under 5 years of age and open enrollment. Continue to advertise the after-school program.

Enrollment/Retention/Student Transferring and Incoming reports – Deanna Hall reported there are 184 students with a retention rate of 86% from last year.

School-wide Goals – Deanna Hall presented the updated student goals developed at the October NMU workshop for 2022-23.

Academics/Intervention – Deanna Hall communicated,

- NWEA/MAP Median Status and Growth Percentile Trends were discussed in both reading and math. There is great progress being made.
- ESLA M-STEP ELA Compared to Similar School and the State of Michigan were discussed. There was significant growth from 2021 to 2022 in ELA.
- ESLA M-STEP Math Compared to Similar School and the State of Michigan were discussed. There was significant growth from 2021 to 2022 in Math.
- The Nations Report Card in Student Performance Across Subjects was discussed in reading and math grades 4 and 8 and showed decrease from last assessment year nationally.
- The ESLA School Goals and Plan for 2022-23 was presented.

- The school had a Halloween Parade and Veteran’s Day program. Michelle Gardner was the head of the Veteran’s Day assembly.
- NMU conducted their program monitor visit, and it went very well. They will follow up with a formal report.
- The Rock Star program, students that are eligible, will go bowling this month.
- The Holiday Performance is December 15, 2022.

Building Report – Nancy Gardner reported that the smaller windows above the newly replaced windows in gym is an additional \$8,875.00. We also received information from Straightline Electric regarding needed outlets etc., in the building. We will wait for the local fire inspector’s report.

NMU Representative Report – Neil Hartman mentioned the MAPSA conference in December. Three people will be attending from ESLA. He also mentioned a service that NMU does that reaches out to alumni letting them know of board vacancies in the area.

OLD BUSINESS

ESSER III – Deanna Hall explained in detail a couple of additions that have been previously discussed with staff. These were,

- TPT (Teacher Pay Teacher) -Teacher support
- Jumping 2 Math Bundle grades K-8
- Acadience Reading K-6 Essential Workshops
- After-school snacks for The Athletic Factory
- Sub pay addition
- MathSeeds
- The board, after questions were answered and discussed, voted to approve the additions. LEA Plan of Use (ARP) – Nancy Gardner reminded the board that minor changes were made in October and that it has been submitted to MDE. The Board accepted the plan “as is”.

NEW BUSINESS

The Athletic Factory – Cliff Thomason gave an update on the after-school program that he operates for East Shore Leadership Academy. The program started with about 130 students and averages now around 75. The program added acoustical guitar and gaming components to their next 8-week session. All with the end-in-mind of preparing students for HS and life in general. He is also looking into swimming lessons at the YMCA and woodworking for 5th-8th grade with a local group. It was mentioned by the board to keep growth at the forefront for next year and alternative places to meet should it be needed.

Emergency Operations Plan – The Port Huron Police Department reviewed ESLA’s present EOY. They made some minor changes with one being they are working on a reunification process for the county which will include all the schools. The board accepted the updates.

Restricted Funds (ESSER/GEER) Audit – Patrick Sweeney explained that a single audit is triggered once a school receives \$750,000 in federal funds. The audit went well.

NMU Monitoring Visit – Deanna Hall reported on the visit under the previous section *Academics and Interventions*.
